1. SITUATION/BACKGROUND

This report aims to provide an update to the Board on relevant matters in my capacity as Chair of the Health Board. It also outlines where I have been required to affix the Common Seal of the Health Board for which endorsement is sought.

This overarching report highlights for Board Members the key areas of activity and where appropriate any associated risks, some of which are referred to within the business of the Board meeting and also highlights topical areas of interest to the Board.

2. SPECIFIC MATTERS FOR CONSIDERATION BY THIS MEETING (ASSESSMENT)

2.1 Health Board Appointments

Chair – I am pleased to confirm that Emrys Elias has been appointed as Chair for Cwm Taf Morgannwg UHB from October 1st for 18 months.

Emrys is currently the Vice-Chair of Aneurin Bevan University Health Board and has considerable experience in leadership within the NHS. After training as a Mental Health Nurse he held several senior clinical and managerial roles at operational, strategic and Board level up until his retirement in 2016 when he was the Director of the NHS Wales Delivery Unit. Our Chief Executive and Executive Team are looking forward to welcoming and working with Emrys when he joins the Health Board in October and I know that Emrys is keen to work closely with you all when he takes up his new role.

I would like to thank you all at this point for your dedication to CTM, and for your personal support to me during my term of office as Chair.

Independent Members

I am pleased to inform you that the Minister for Health and Social Services has agreed to appoint Carolyn Donoghue as Independent Member (University) to Cwm Taf Morgannwg University Health Board for 4 years. Her appointment commenced with the Health Board on the 4th August 2021.



Cllr Phillip White (Independent Member, Local Authority) term of office is coming to end in November. I would like to personally thank Phil for his contribution to the Health Board over the last few years.

Kieron Montague (Independent Member, Community) term of office is coming to an end on the 30th September. Keiron has been a valuable member of the Board for many years and I would like to personally thank him for his hard work and contribution to the Board and wish him every success for the future.

Interviews were held last week (20th September) for Keiron's successor and we are awaiting a decision from the Minister on an appointment. I have recently written to the 3 Local Authorities seeking nominations for a Local Authority Independent Member to succeed Phil, and will keep the Board briefed on progress.

from the stillbirth category into the context of the Health Board's ongoing Maternity and Neonatal Improvement Programme.
