## 1. SITUATION/BACKGROUND

- 1.1 Cochlear implants and bone conduction hearing implants (BCHI) are a specialised service commissioned for Welsh residents by Welsh Health Specialised Services Committee (WHSSC)

- 1.2 In 2019, urgent temporary arrangements were put in place for cochlear implant services when the service provided at Princess of Wales Hospital became unviable. Since 2019, services have been centralised at Cardiff and Vale University Health Board.
- 1.3 Bone conductor hearing implant services for the South Wales population remain provided by three health boards: Swansea Bay University Health Board, Cardiff and Vale University Health Board and Aneurin Bevan University Health Board.
- 1.4 In order to inform both the future commissioning model and engagement requirements, 3 pieces of work have recently been undertaken:
  - A clinical options appraisal,
  - An external assessment of the options against clinical standards; and
  - A financial options appraisal.
- 1.5 The outcomes and recommendations of this process were presented to WHSSC's Joint Management Group in July 2022 and supported by the Group. These were ratified by the Joint Committee on 6<sup>th</sup> September 2022.
- 1.6 The outcome of the assessments was to seek to commission a single implantable device hub for both children and adults with an outreach support model. This now requires a formal engagement process in line with 'Guidance on changes to services in NHS Wales'

## **2. SPECIFIC MATTERS FOR CONSIDERATION BY THIS MEETING (ASSESSMENT)**

- 2.1 A targeted engagement process is proposed. This will comprise the following components.
  - A Letter to all current patients/carers, (*note those already within the service, and those on a waiting list*) including engagement materials, and outlining the current position, the case for change, options that have clinically been considered and a preferred option of future delivery;
  - A Letter to all clinical teams including engagement materials, and outlining the current position, the case for change, options that have clinically been considered and a preferred option of future delivery;
  - Publication of the engagement process and materials on HB websites and consideration of cascade through stakeholder reference groups (SRGs); and

- Cascade of documentation to a number of stakeholders to enable broader view.
- 2.2 The full process of engagement is set out in the attached report and supporting documents provided by WHSSC.
- 2.3 Two members of staff employed by Cwm Taf Morgannwg University Health Board will be affected by the service change. Both team members have received early notification of the proposals and will be fully engaged in the process.
