2. PURPOSE OF THE DIGITAL & DATA COMMITTEE

The purpose of the Committee is to advise and assure the Board in discharging its responsibilities with regard to the quality and integrity; safety, security and appropriate access and use of information & Data, to support health improvement and the provision of high quality healthcare.

The Committee will seek assurance on behalf of the Board in relation to the Health Board's arrangements for appropriate and effective management and protection of information (including patient and personal information) in line with legislative and regulatory responsibilities.

The Committee will also provide advice and assurance to the Board in relation to the direction and delivery of the Digital and Data Strategies to drive continuous improvement and support digitally enabled health care to achieve the objectives of the Health Board's Integrated Medium Term Plan (IMTP).

	<p>The Committee Endorsed for Board Approval the revised Committee Terms of Reference that will be presented to the Board at its meeting to be held on 31 March 2022.</p> <p>The Bridgend and CT Aggregation Plan Highlight Report was received. The Committee noted the update on progress with regard to the disaggregation of ICT services support from Swansea Bay UHB.</p> <p>The Committee received at 'In Committee' the National Infrastructure and Services Directive – Cyber Assessment Framework.</p>
ASSURE	<p>An update was received and noted on the Organisational Risk Register entries related to ICT risks with a score of 15 or more, recognising the updated risks and new risks escalated this period.</p> <p>The Committee received an update on the Internal Audit Follow Up Report on IT Service Management which had received "reasonable assurance" rating and noted the management actions. The Committee extended their thanks to colleagues on the positive progress to date and the successful appointment of a new Head of Service Management, due to start in the Spring of 2022.</p> <p>An Internal Audit Report on Bridgend and ICT Aggregation was received. The Committee noted that the report had received a "limited assurance" rating and noted the management actions and progress being made against the recommendations.</p> <p>Highlight reports from the Information Governance Group meeting held in January and March 2022 were received and noted.</p> <p>An Audit Report from the Information Commissioners Office (ICO) was received. Members noted the draft action plan and extended thanks to all colleagues involved in supporting the ICO audit.</p> <p>The Committee received the Critical Incidents Report and noted the critical incidents affecting digital services which have had significant impact on users and services from November 2021 to March 2022, the process for logging and reporting them, and the mitigating work put in place to reduce a re-occurrence.</p> <p>A report on the Integrated Medium Term Plan – Digital Programme for 2022-23 was received. The Committee reviewed the detail of the strategic programme for delivering digital and data services and considered that it supports delivery of the Health Board's strategic intentions at the requisite pace, is detailed and well thought through in terms of logical process and acknowledges the strategic environment faced by the Board.</p> <p>The Committee received a report on the Digital Programme Assurance, noting progress and recognising the assurances around the mitigation to manage risks.</p>
