1. SITUATION/BACKGROUND

This report aims to provide an update to the Board on relevant matters in my capacity as Chair of the Health Board. It also outlines where I have been required to affix the Common Seal of the Health Board for which endorsement is sought.

This overarching report highlights for Board Members the key areas of activity and where appropriate any associated risks, some of which are referred to within the business of the Board meeting and also highlights topical areas of interest to the Board.

2. SPECIFIC MATTERS FOR CONSIDERATION BY THIS MEETING (ASSESSMENT)

2.1 Health Board Appointments

Chair – Colleagues will be aware that my term of office finishes at the end of September 2021, and that I have decided not to seek a second term. Welsh Government Public Appointments Branch are leading the process to advertise and recruit a new Chair to commence in October 2021.

Vice Chair – Maria Thomas is officially retiring at the end of May 2021. I am so very grateful for Maria to have continued her role beyond the maximum period and for a smooth transition for the new Vice Chair. I would like to personally thank Maria for the outstanding service she has provided to the Health Board and for being a valuable member of the Board. I would like to wish Maria a very happy retirement and all the very best for the future. I am delighted to inform you that Jayne Sadgrove has been appointed as the new Vice Chair for Cwm Taf Morgannwg UHB and is due to commence post on the 1st June 2021.

Independent Members – The process of recruitment has commenced with Welsh Government for Independent Members whose Term of Office are due to end in the Autumn. The Board will be notified in advance of any new appointments.

Associate Member – Gio Isingrini's Term of Office came to an end in January 2021. Lisa Curtis Jones has been successful in securing the appointment of the Associate Member for Cwm Taf Morgannwg. Lisa is due to commence her role on the 1st June 2021. The Chair would like to



welcome Lisa who is observing todays' Board Meeting ahead of her official start date.
