# 1. PURPOSE

- 1.1 Due to timing of meetings, the IG Group have not met since the last report was presented to the Digital & Data Committee. # 2. HIGHLIGHT REPORT

# ALERT / ESCALATE

**Positive Escalation** -the Information Governance Team continuing to maintain high compliance with data protection and Freedom of Information legislation during a period of increased demand in addition to general operations queries. They continue their commitment to ensuring training and awareness is rolled out across the organisation.

**Data Protection Impact Assessments (DPIA)** -the IG Team are experiencing an increase in staff requiring such assessments to be undertaken. IG have on occasion been given short notice (such as 24 hours,) to carry out robust reviews prior to a programme or system going 'live'. This has been added on to the risk register and senior members of staff have been reminded to involve the governance team at the initial discussions whenever possible to avoid delays in implementing new projects.

#### ADVISE

**Policy Development** – the IG team are in the process of collating comments from key staff on the following policy/procedural documents:

 Records Management Policy and Records Management Procedure

A policy review will be undertaken by the Team for any additional local policies that require updating. In addition to this, there is also a national sub group that is currently reviewing the All Wales policies which will be presented to the Committee for approval once endorsed by the All Wales Information Governance Managers Advisory Group (IGMAG).

**Information Governance** Activity—the Information Governance Team have seen increased demand in activity and requests for support over the past few months. This activity is listed below:

### **Incidents:**

The Team have received and investigated 75 incidents since November 2020. A breakdown is shown below:

INFORM	Appointment-Covid 19 Pandemic Information Manager – the Team continue to look at the options to support the Health Board in managing and preserving the written, electronic, and photographic and oral history of the Health Board wide COVID-19 pandemic response.  The Head of Information Governance is currently compiling the response to the Governance Toolkit for submission in March 2021. This will also be undertaken for hosted bodies. The Toolkit has already been submitted for the managed GP practices.
