## 2. HIGHLIGHT REPORT

ALERT / ESCALATE	The patient portal PKB which is a SB project and a legacy solution from the Bridgend merger requires either the contract to be extend or terminated by end of November. A paper will be presented to Exec Board for the decision. Patient portal is a HB requirement and will be taken forward as a new project and procurement
	It was noted that the revised reporting line for DHSSG was to Management Board (MB) with the ICT Boards now reporting to the ICT Senior Management Team (SMT) meeting.  It was agreed the ToR should be rewritten in line with the MB ToR and membership should be extended to reflect a Health Board (HB) wide group going forward.
ADVISE	There was a discussion around the purpose of the group and assurance aspects of work programme delivery by advising, determining, managing and appraising work programmes.
	It was suggested that the group be more Informatics driven with information and performance on the agenda and covering relevant aspects of primary, community and integrated care along with the impact to secondary care.



ASSURE	The O365 mailbox migration is complete and moving to next phase of One Drive roll out. There are now options around our license shortfall.  WEDS project is progressing while the hardware refresh is being undertaken with EMIS and SB  DPN was reported as red while we put in place mitigating actions with the agreement this will soon be moved to amber/green  All National projects, Wellsky, LINC, WICIS, Open eyes are fully supported by the HB and have roll out plans in place
INFORM	A paper was presented to DHSSG regarding ICT pressures around both capital and revenue for staff and equipment to support the increase in workload and projects. This has been taken to management board for consideration by the DoF  With regards to the disaggregation of POW from SB there was a paper updating the group that 3 workshops had been held to date with a paper due to go to JMG on the 1st December. The TUPE of the POW staff was achievable by 31st March 2021 while the clinical systems will require considerable more planning
