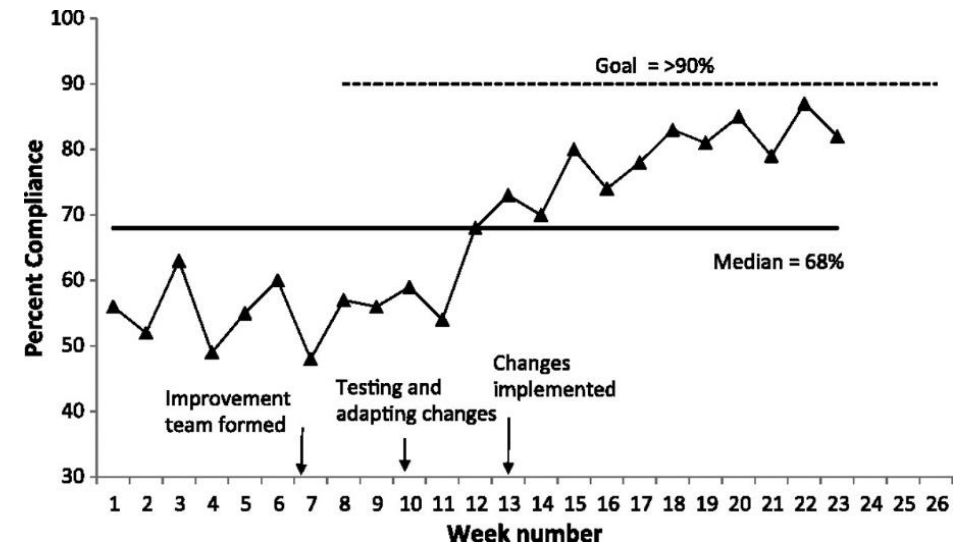

Time series data and its place in improvement

Measurement for improvement does not have to be complicated. Tracking a few measures over time and presenting the information well is fundamental to developing a change that works. Time series measurement can show us a number of important pieces of information:

- how well our current process is performing
- whether we have reached an aim
- how much variation is in our data/process
- the impact of tests of change
- whether the changes have resulted in an improvement
- whether a change has been sustained





Using the Dashboard for Improvement

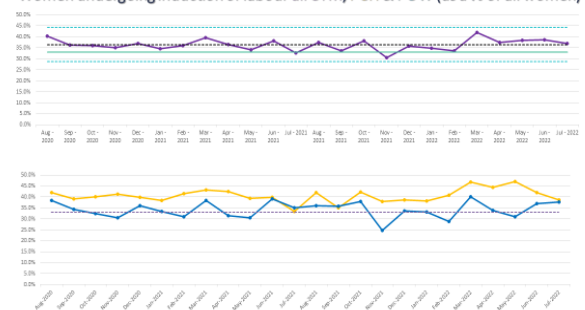
Key maternity metrics are presented at a number of multi-professional forums for discussion and identifying areas in need of improvement, including:

- Labour ward forum
- Joint governance
- Operational leads meetings

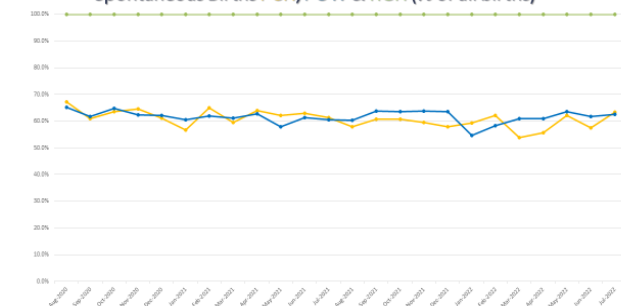
The data are presented in time series format for the preceding 2 years to allow easy identification of signals of change.

Opposite are some examples of the maternity dashboard data time series charts presented.

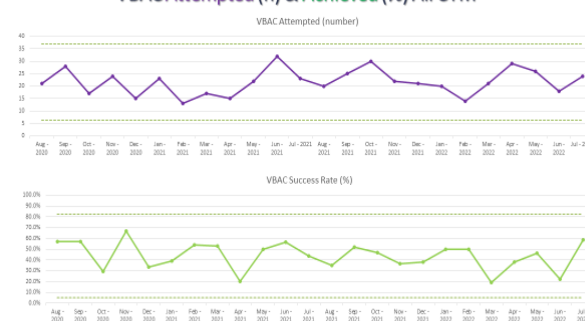
Women undergoing induction of labour all CTM, PCH & POW (as a % of all women)



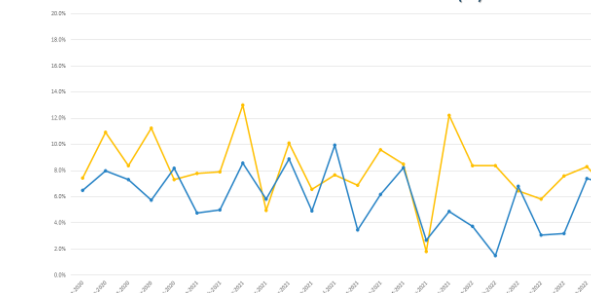
Spontaneous Births PCH, POW & RGH (% of all births)

Term Admissions to NNU PCH & POW (%)



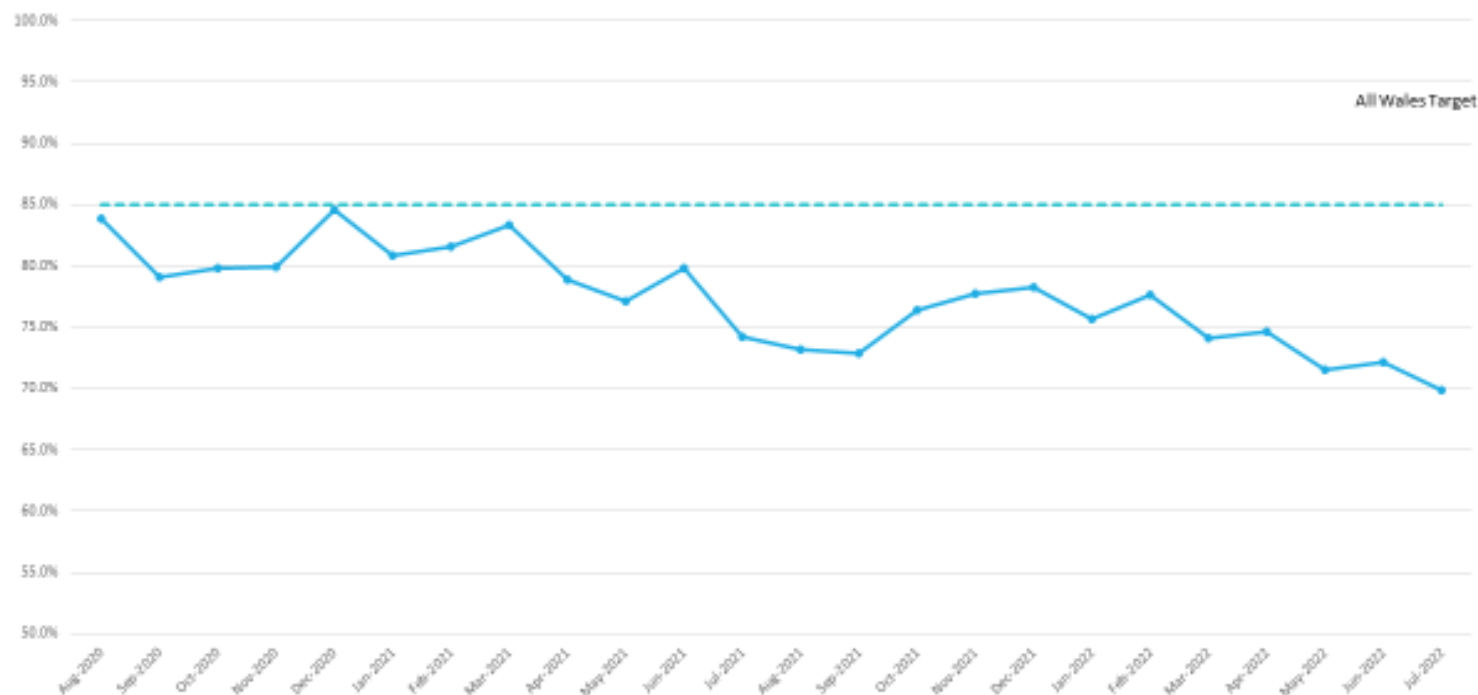


An example of monitoring the dashboard for signals of change

When this chart was presented at a Governance meeting, it identified an area in need of improvement and led to the development of a quality improvement project to increase the number of women whose pregnancy is booked by 10 weeks gestation.

As improvements are implemented, this will continue to be monitored and will show us the impact of the changes we're making.

New Initial Assessments by 10 Weeks Gestation CTM (%)



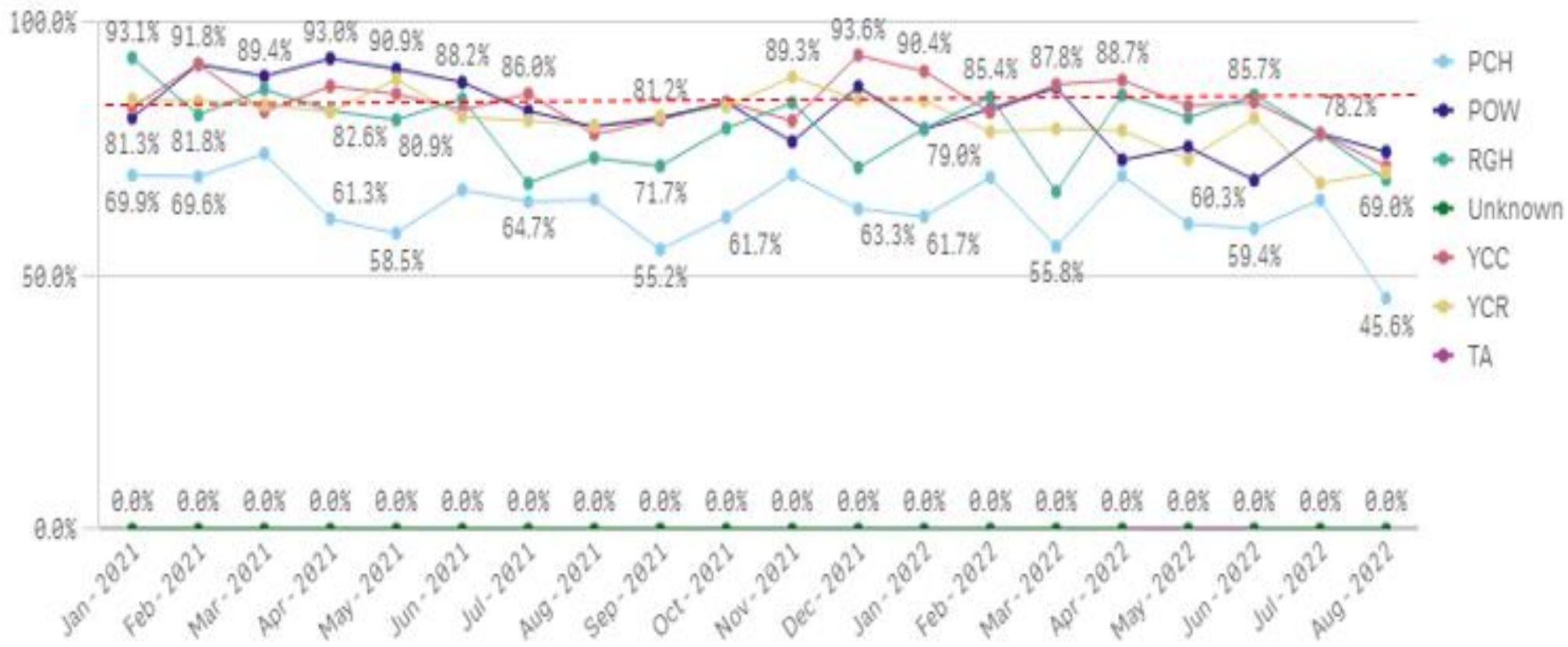

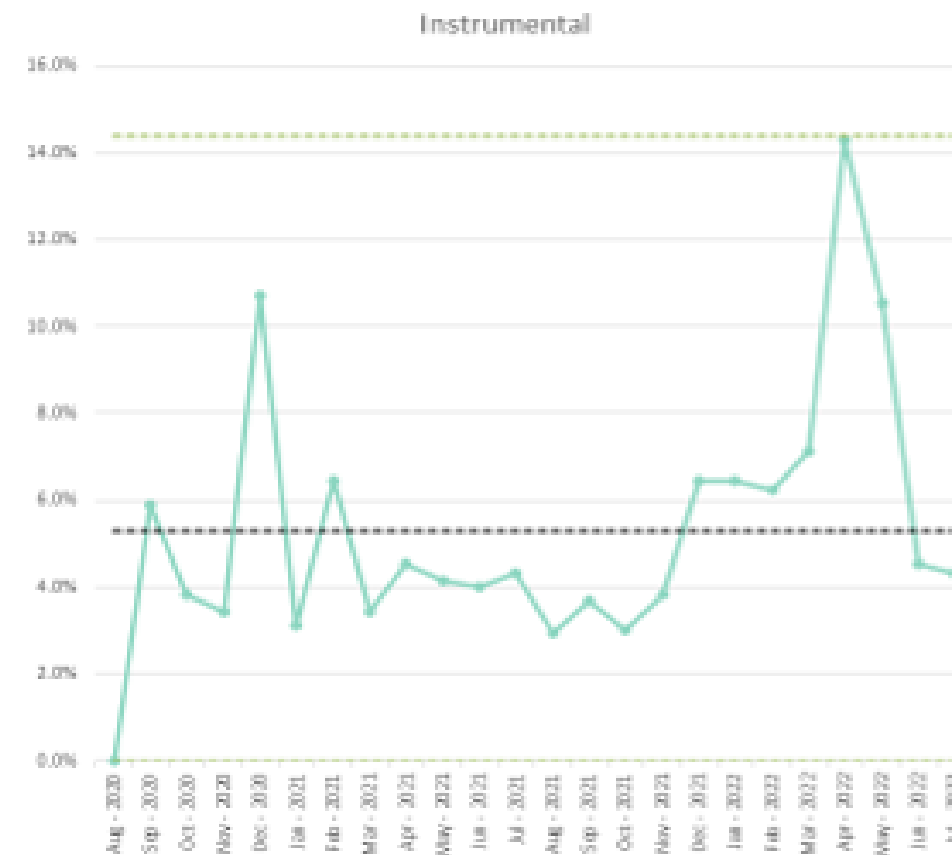
Booking by 10 completed weeks





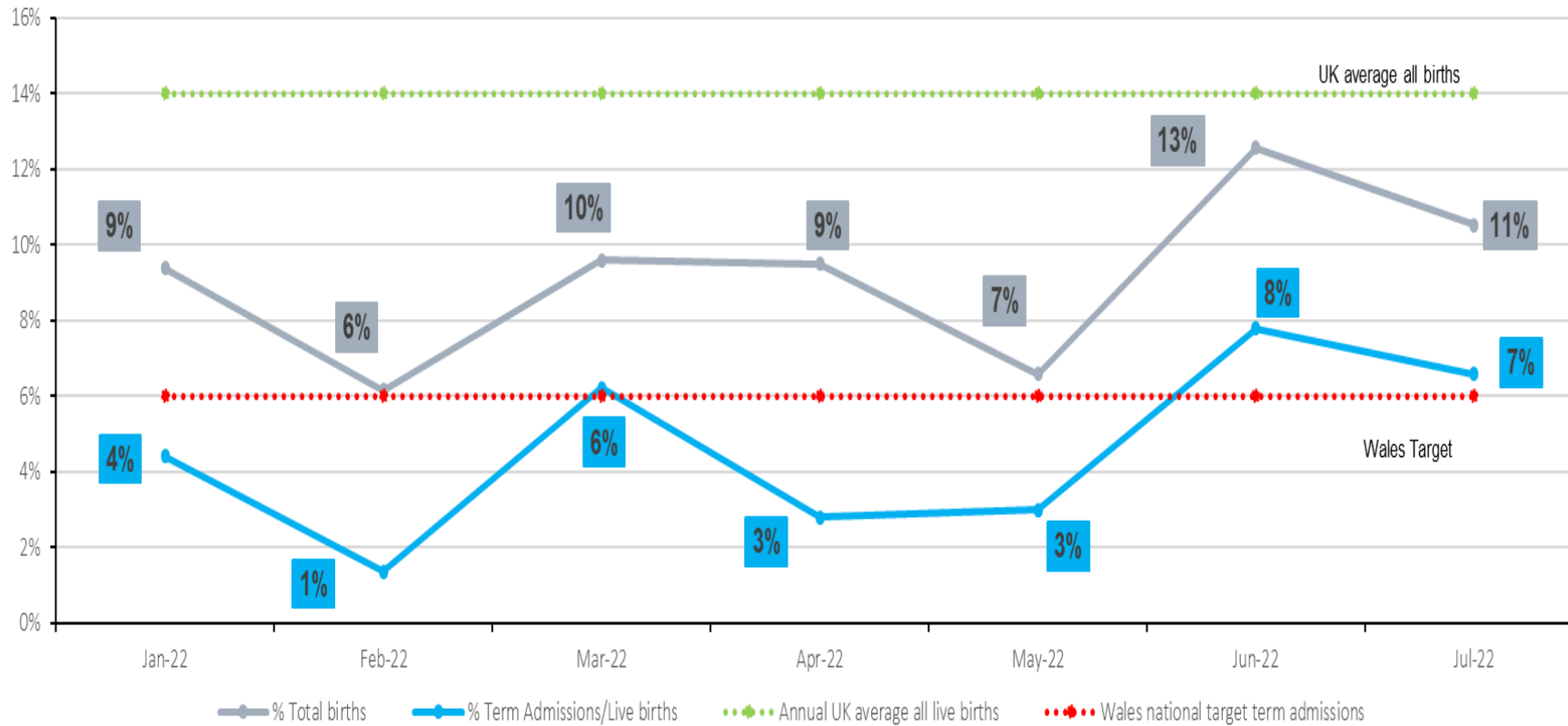
Using continuous data for improvement

- When this time series chart was shared in May 2022 showing a significant increase in 3rd & 4th degree tears following instrumental birth, it prompted a deeper dive into the issue and plans for improvement.
- Data presented in August showed a fall in the % of women experiencing an OASI
- This will continue to be monitored over time





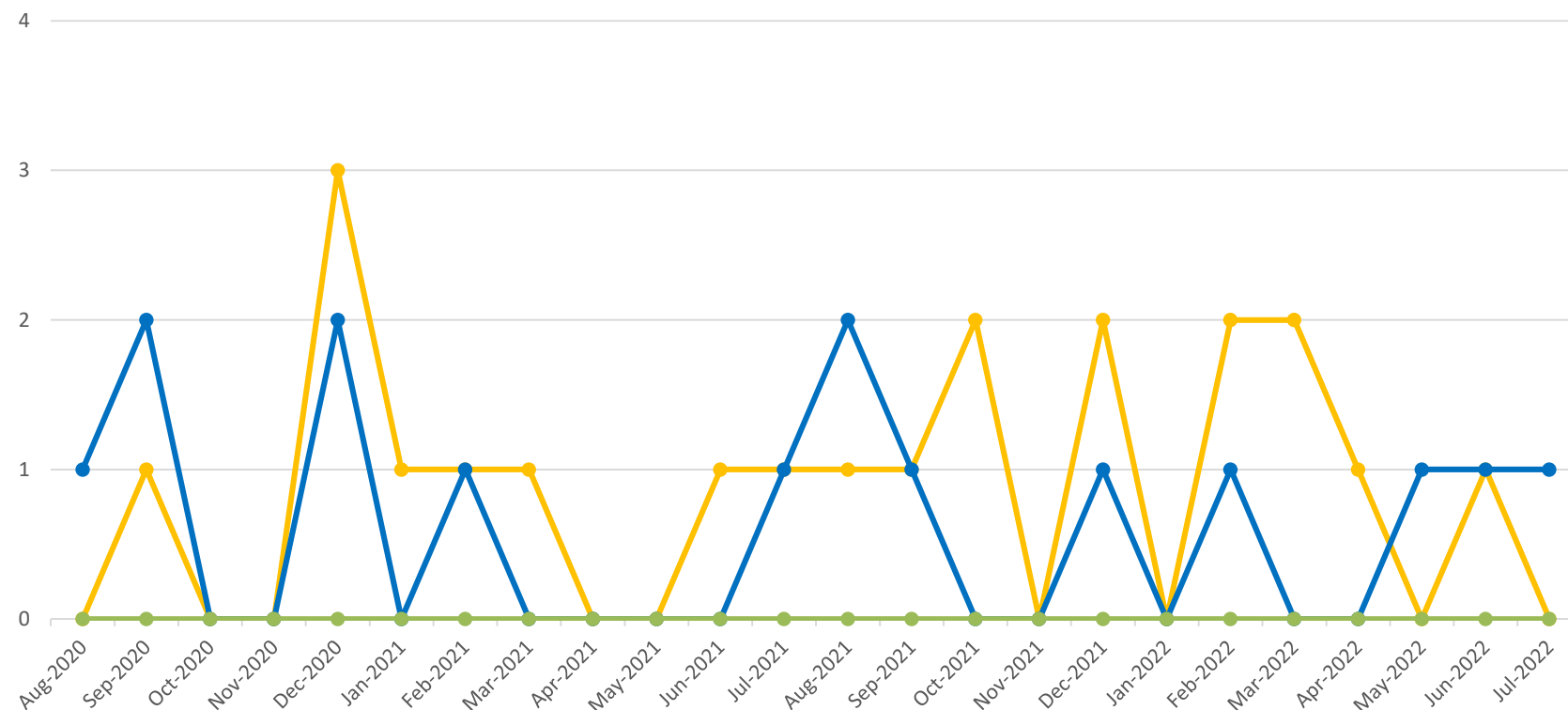
Term Admissions to the Neonatal Unit





Stillbirths

- CTM is not an outlier for stillbirth rates (MBRRACE 2021)
- These data appear very variable due to low numbers, however rates are stable with no signals of change or data outside normal variation.
- All cases are reported to DATIX and receive a rapid review within 72 hours.
- CTM's stillbirth review forum and Rainbow Baby Clinic are in development to provide enhanced continuity of carer for families experiencing pregnancy loss and planning for next pregnancy

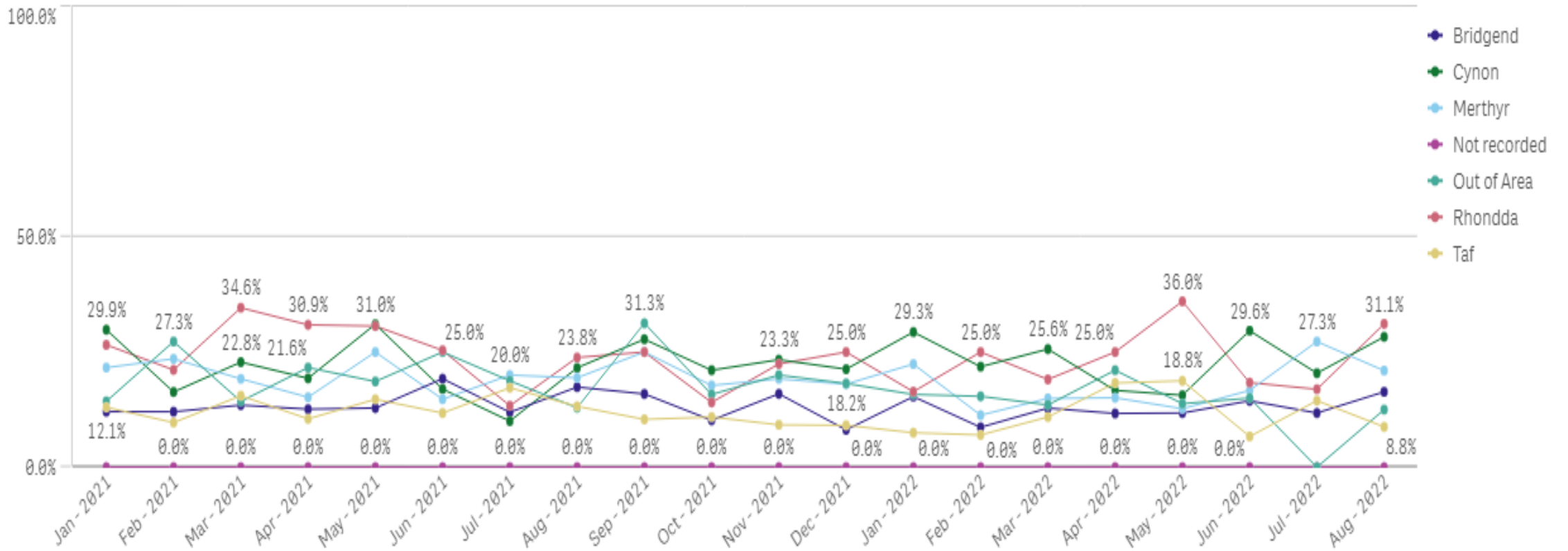

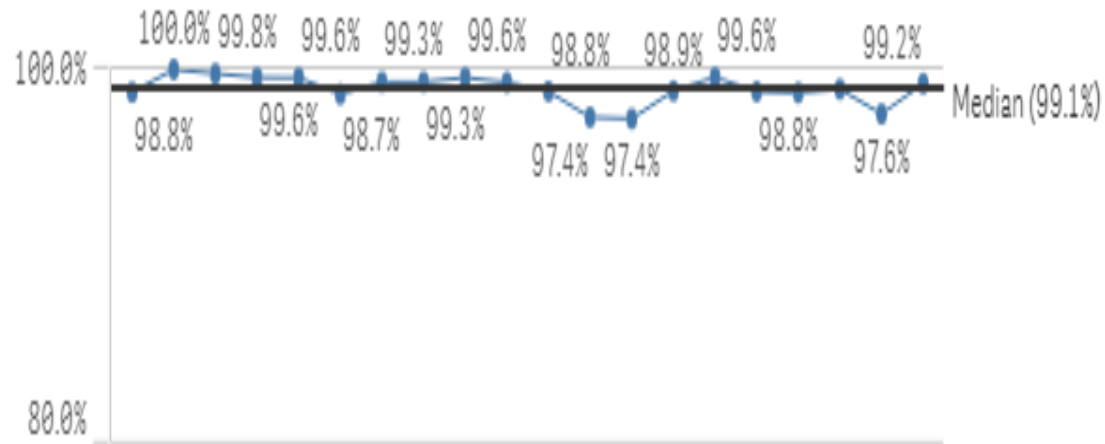


% of women smoking at booking by area

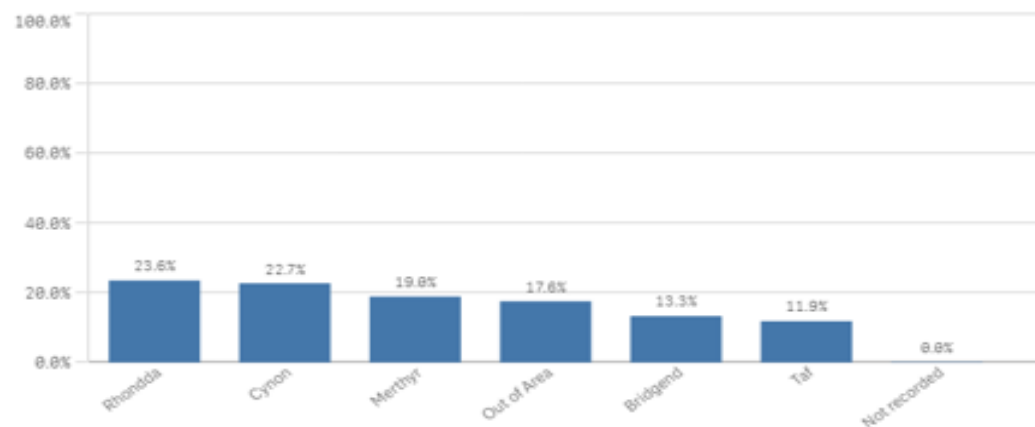

Data quality are generally very good across the Health Board, with a 99.1% median completion rate.

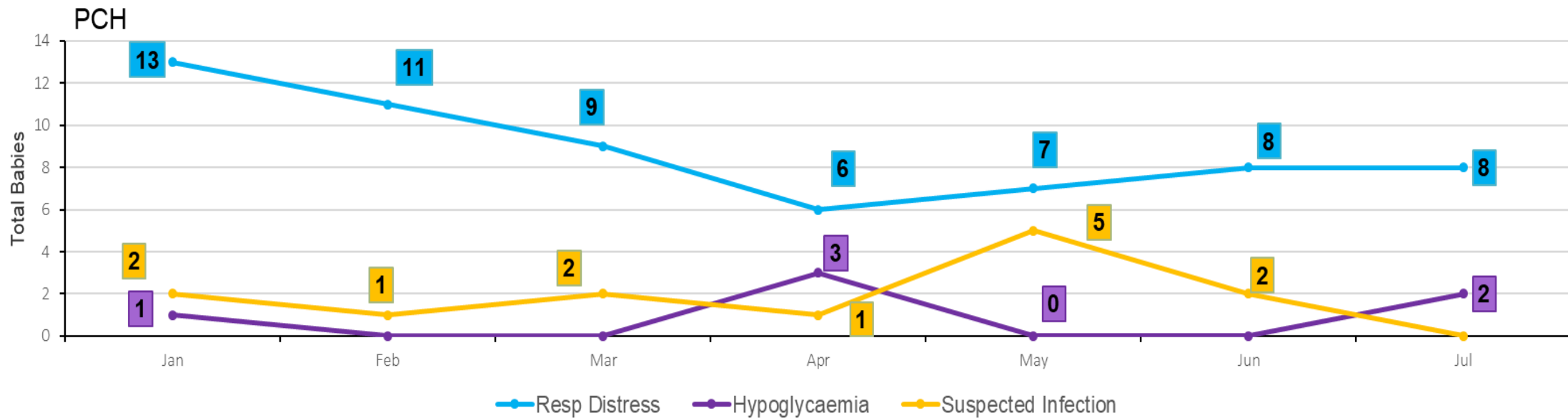


Smoking in pregnancy rates are highest in Rhondda and lowest in Taf.

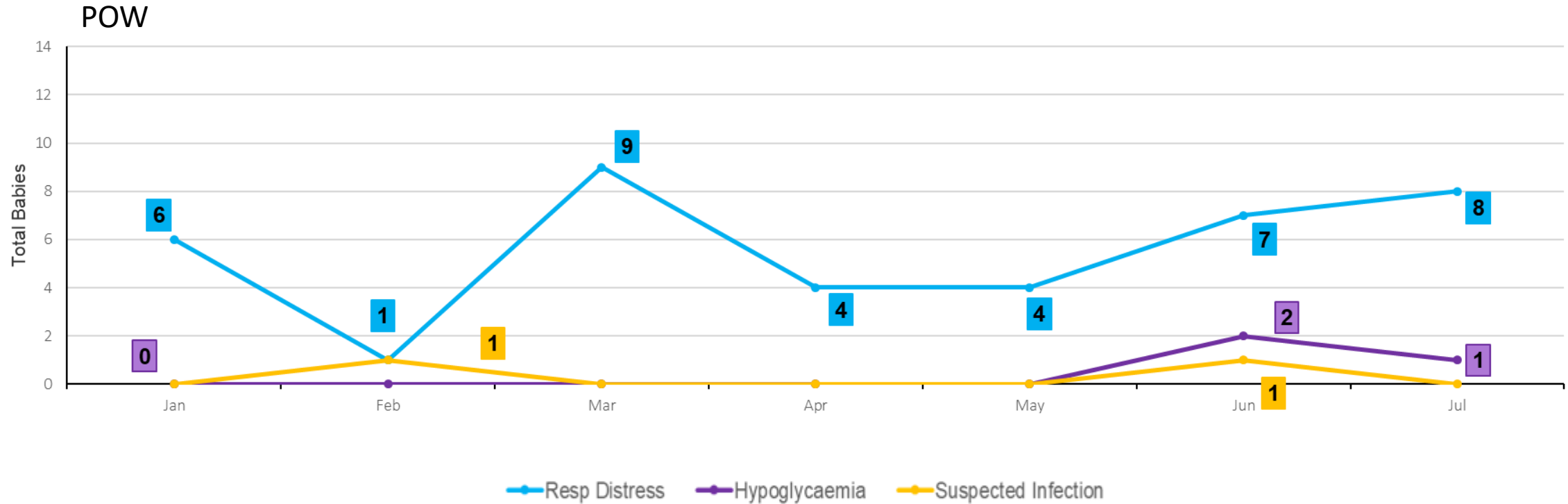
Top 3 reasons for admissions - >37 Weeks (inborn)

Next Steps

- Multi-professional dashboard consultation (July 2022). ✓
- Review 'red flags' and 'goals' against national benchmarking (July 2022). ✓
- All red flags will be removed. All goals will be removed unless WG set a target ie bookings by 10 weeks gestation.
- Digital systems scoping meeting (13th July 2022). ✓
- Procuring data analysis software to support improved data presentation, particularly for metrics with low monthly numbers (ie stillbirth, 3rd & 4th degree tears).
- Align dashboard with evolving All Wales Maternity Dashboard, and wider programme of Digital Maternity Cymru work (ongoing as All Wales work progresses).
- 'Go Live' date of updated dashboard- September 2022. On track.
- Cross-referencing against CHKS score cards will start on a quarterly basis, aligning with reporting cycles. These are generated quarterly against a set of agreed metrics and will provide another dataset against which to validate maternity data. CHKS data is input when notes are returned for coding.
- Ensuring all staff groups know how to access dashboard via SharePoint.

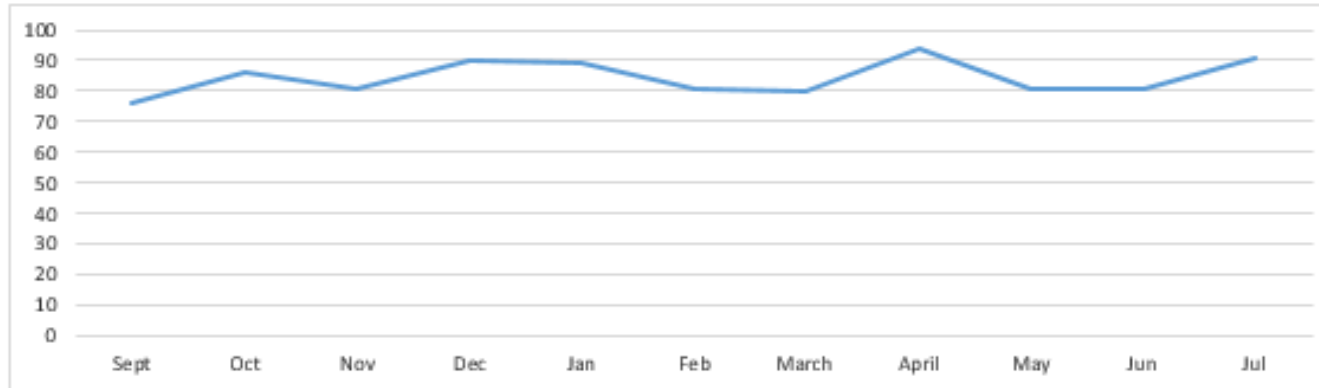

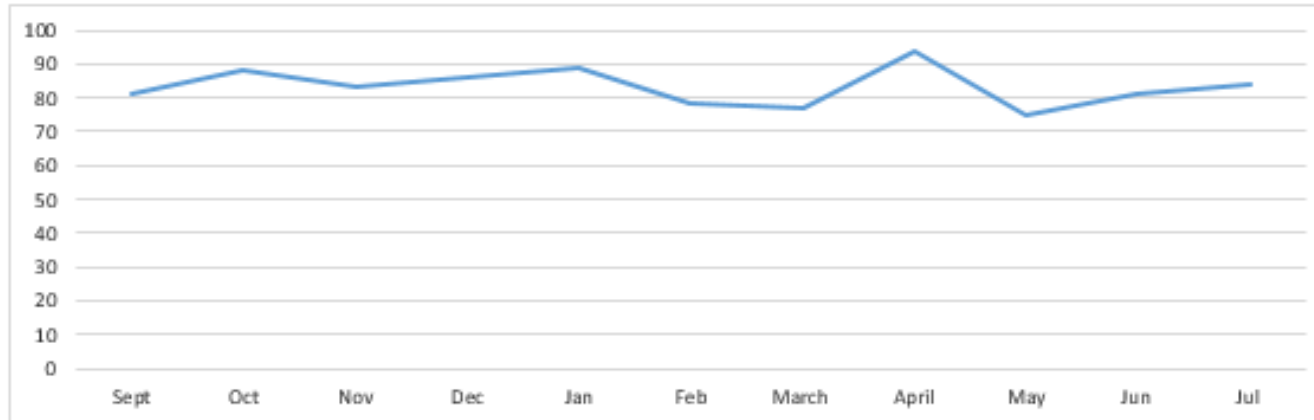
Thinking about the care you received during your pregnancy and birth journey, were you treated with respect and dignity?

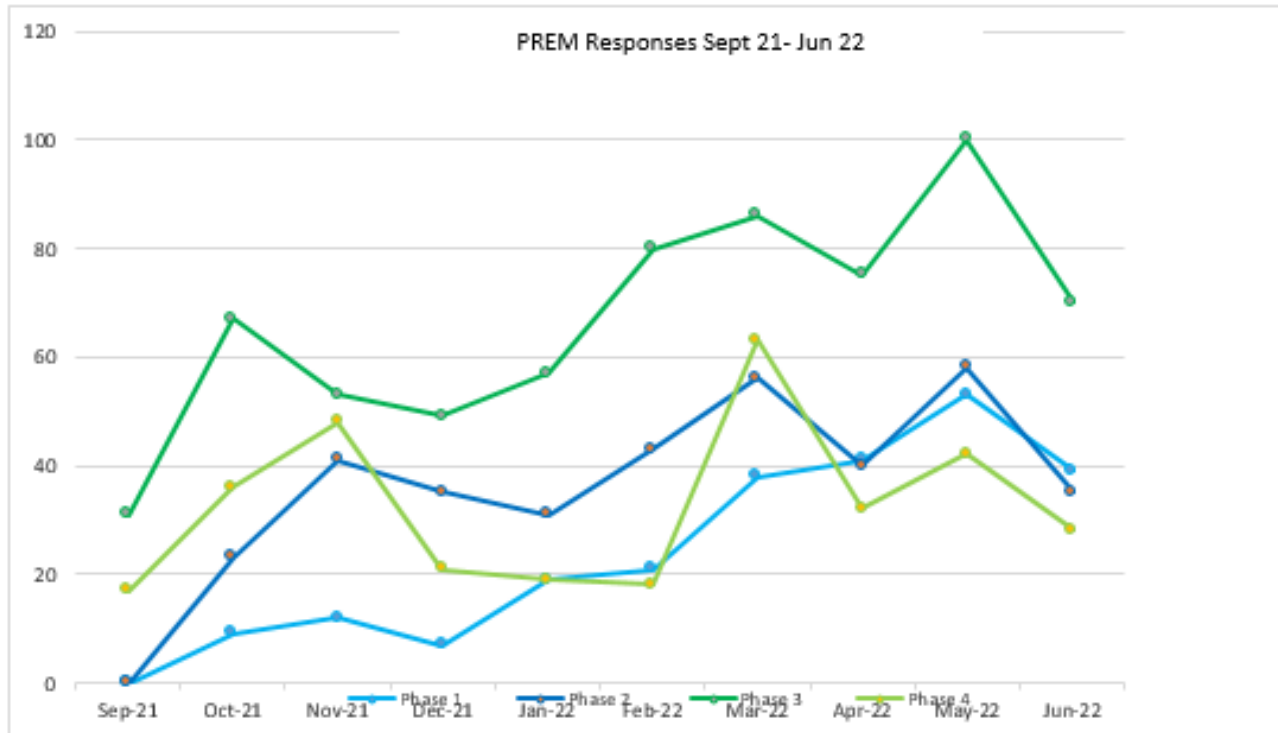
Through our patient Reported Experience measure (PREMS) women tell us consistently that they felt they were treated with dignity and respect, kindness and understanding.

Patient Reported Experience measure (PREMS) was launched in September 2021, with increasing uptake since. June shows as decrease as not all responses received yet.

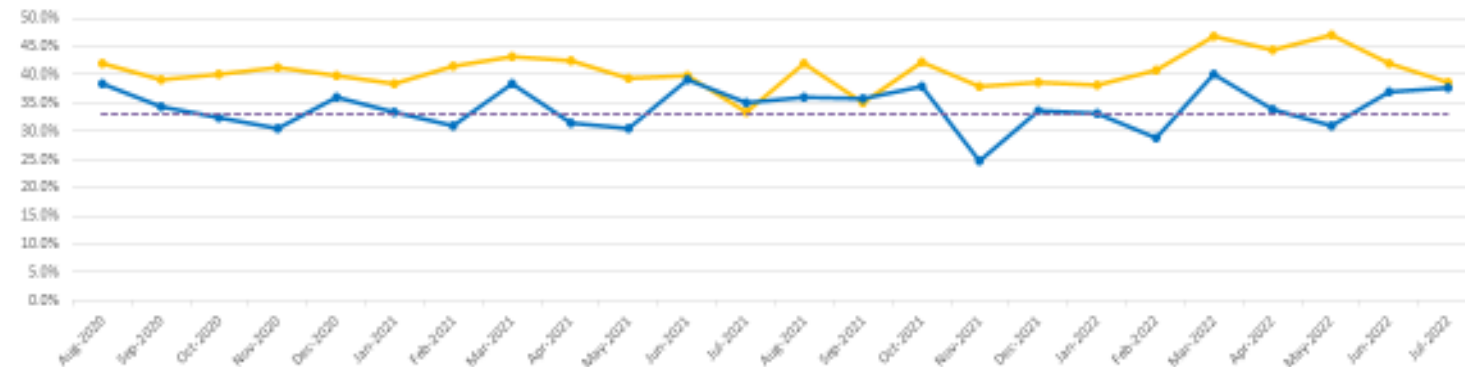
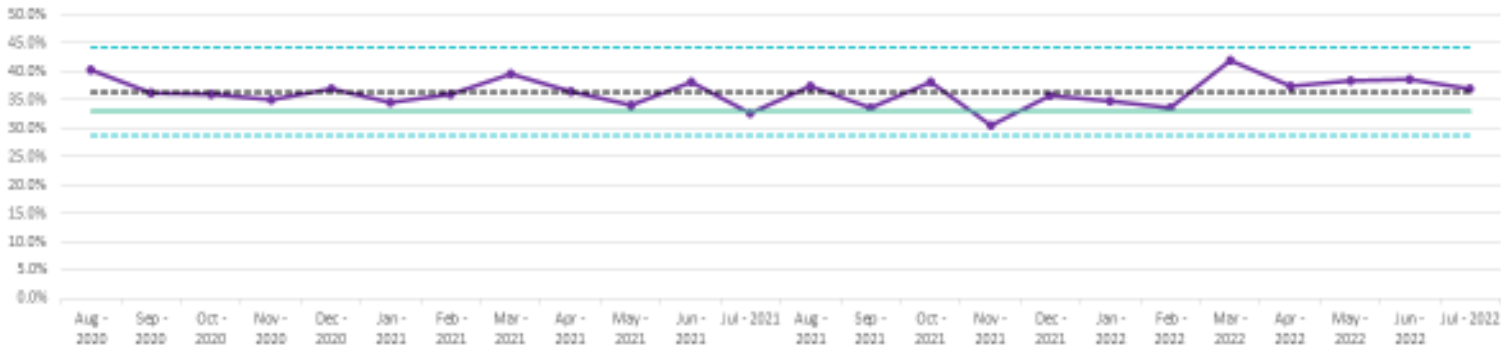
The experience data is now a core part of maternity metrics reporting.

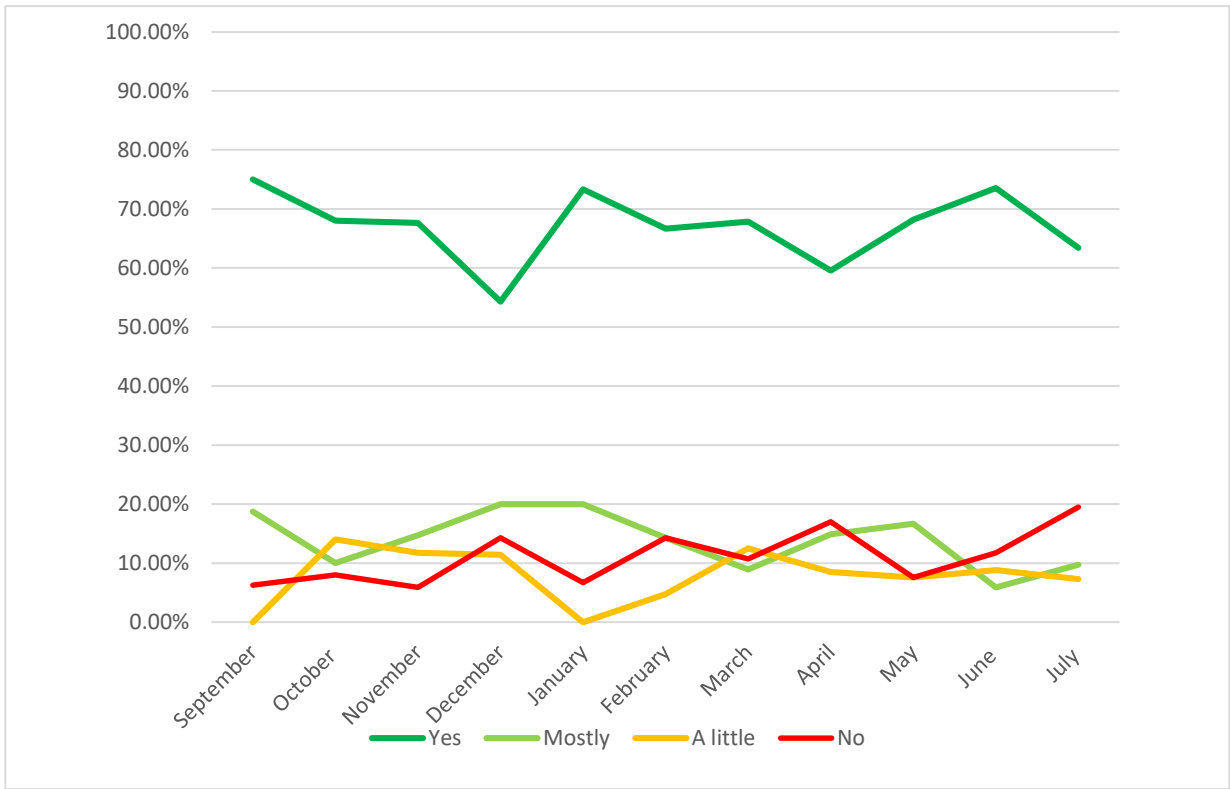
Rates stable- normal variation but no trend or shift seen over 2 year period.

Induction of Labour rates are increasing across the UK. No target set by WG, as rates impacted by many factors, including local population demographics.

IOL improvement group is undergoing a refresh with a QI methodology approach. Aim is to improve the quality, safety and experience of care. This includes adherence to guidance and joint decision making.



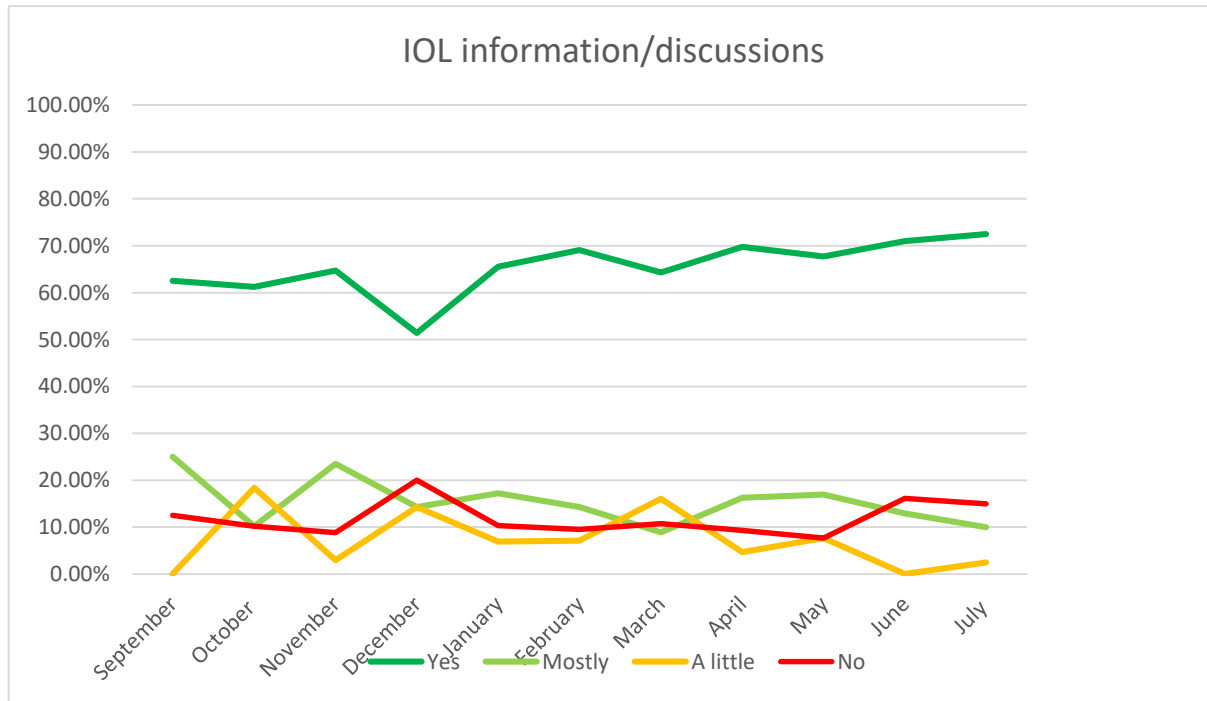

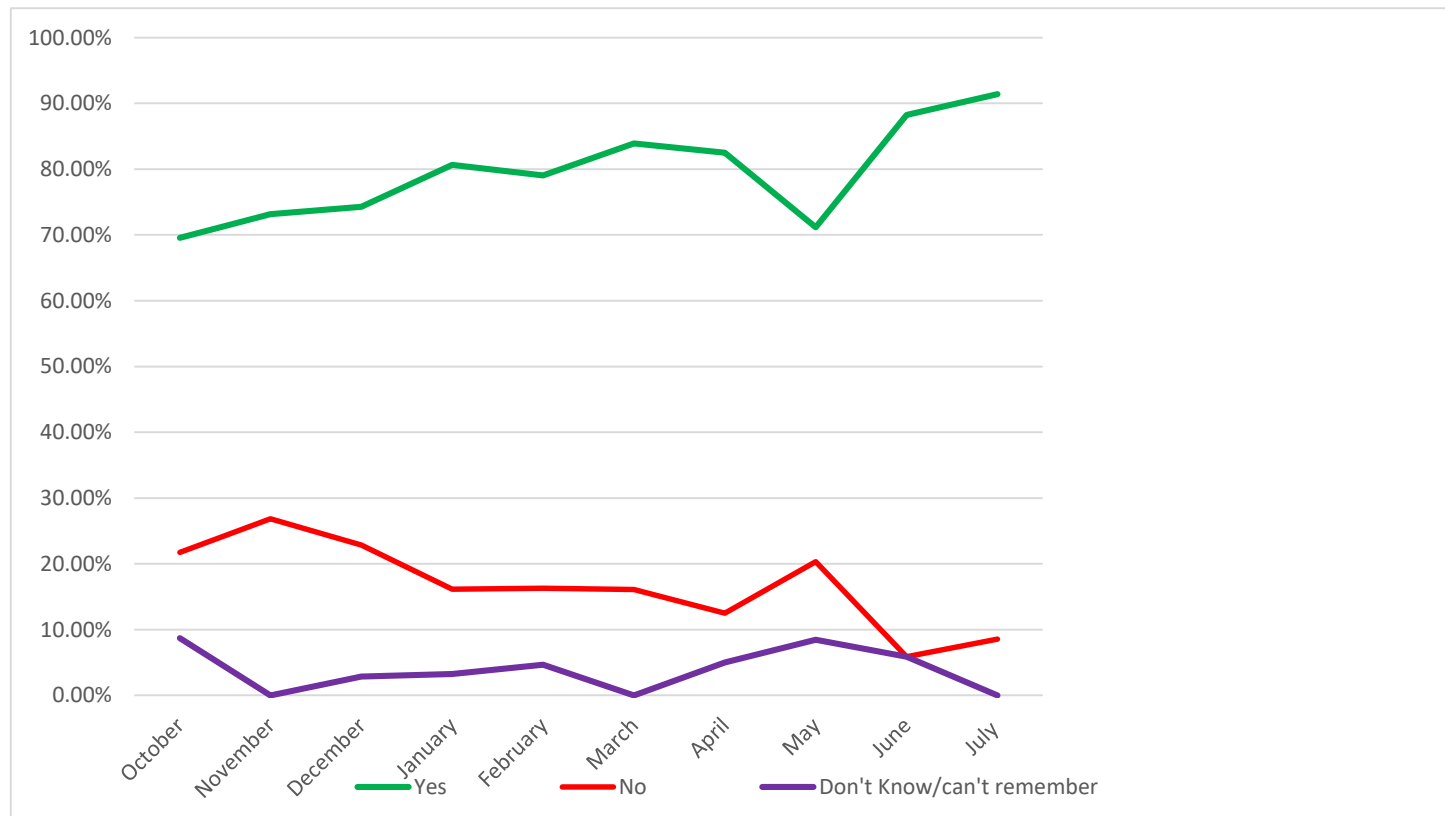

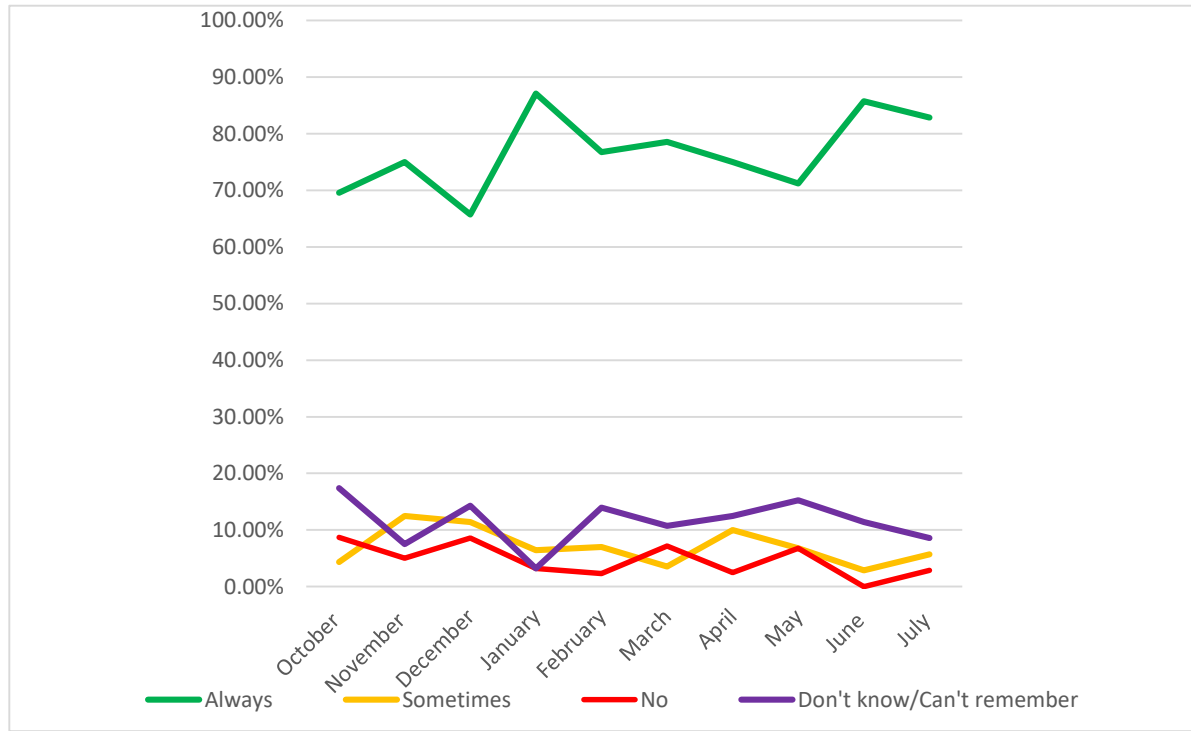

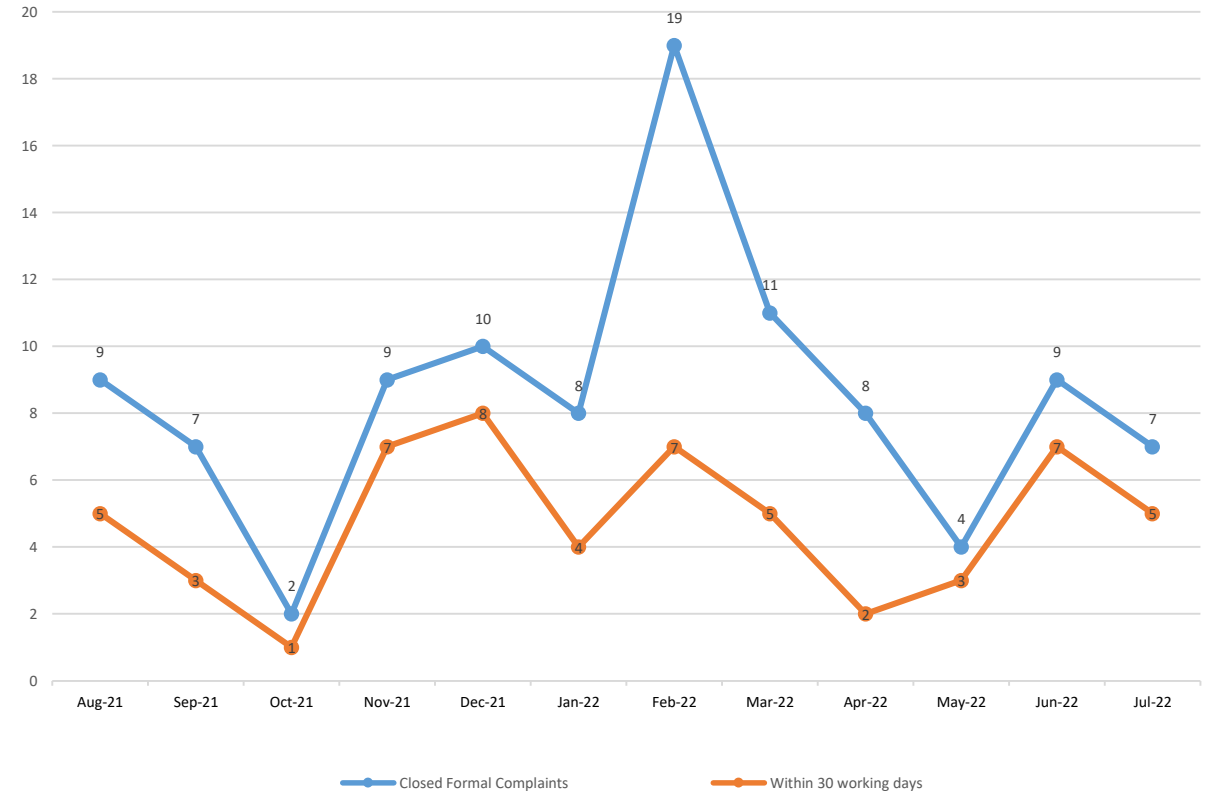


Overall Concern Compliance May-July 2022 (Mat, Gynae, ISH)

Overall Obs, Gynae & Sexual Health 30wd % Compliance

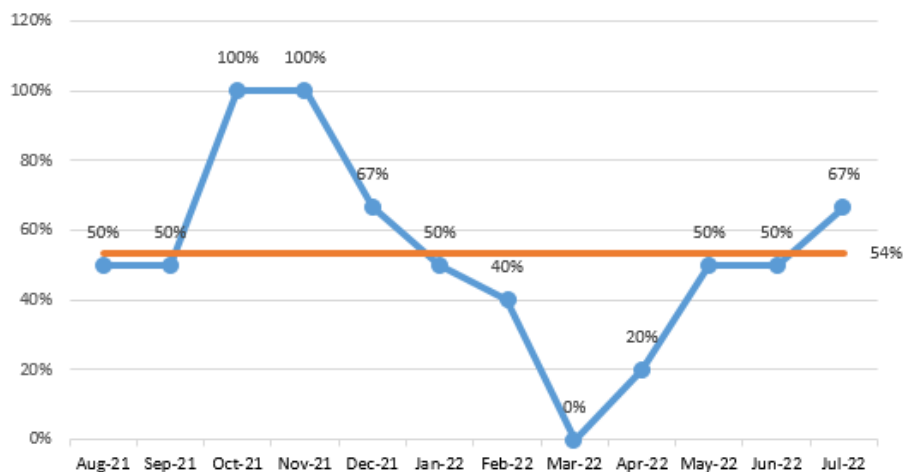


Overall Obs, Gynae & Sexual Health Closed Formal Complaints

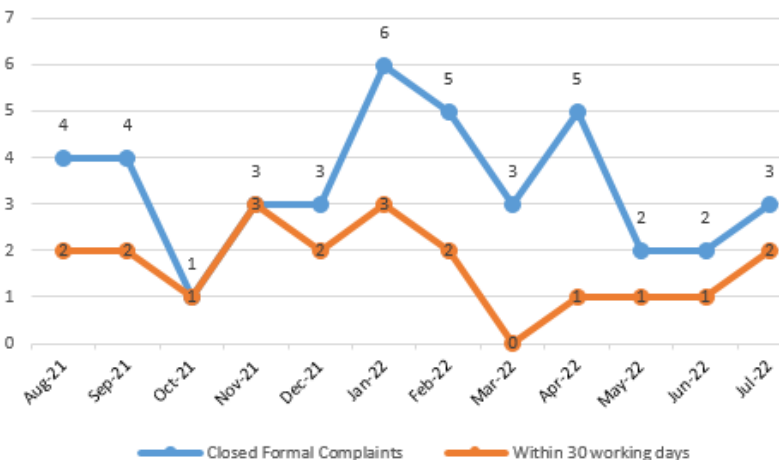




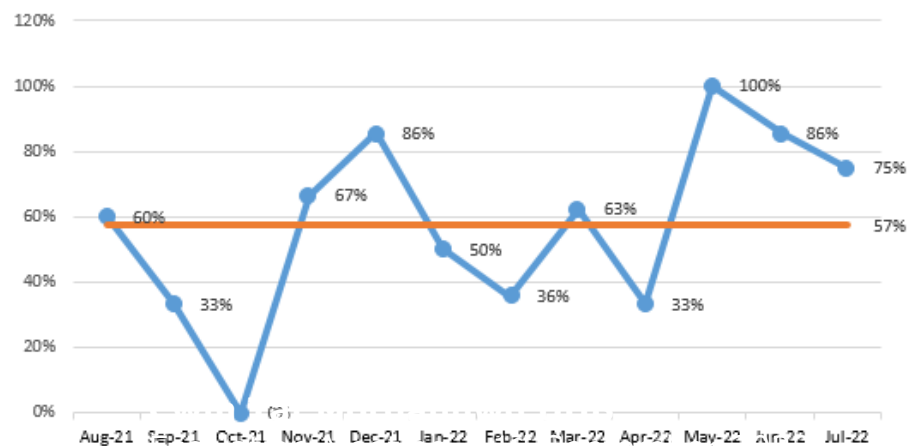
Bridgend ILG Obs, Gynae & Sexual Health Compliance 30wd Formal Complaints



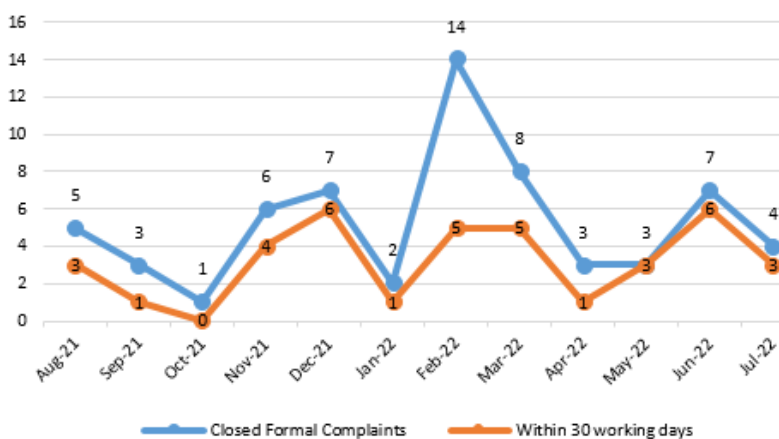

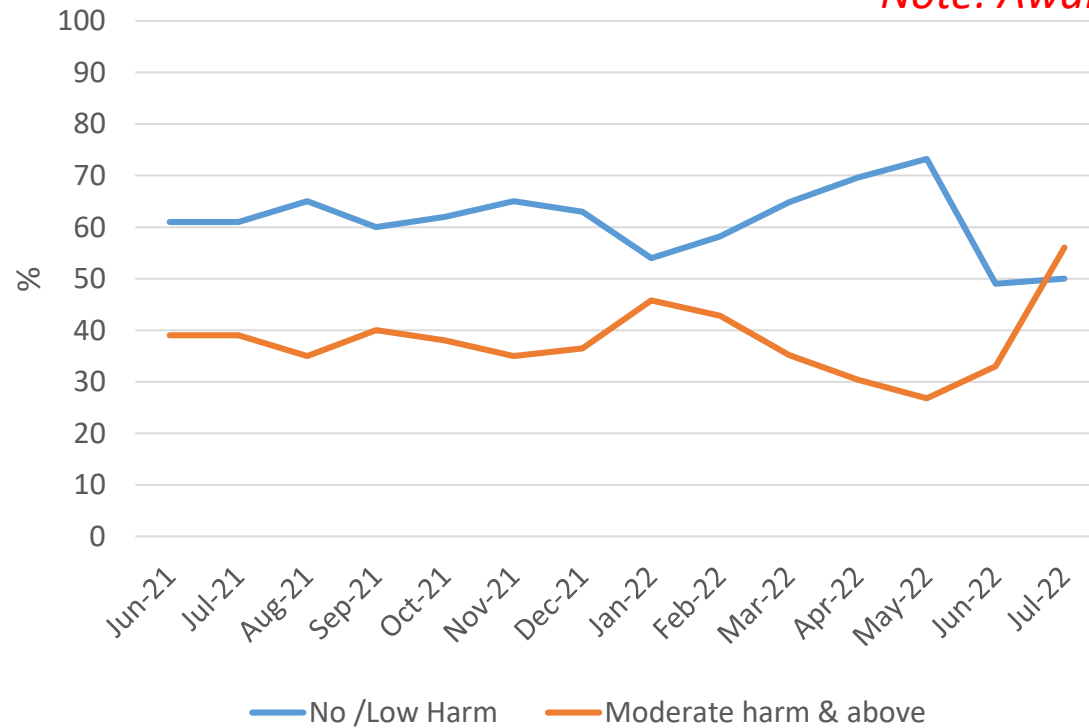

Graph indicates low harm has decreased but moderate harm showing a slight increase.



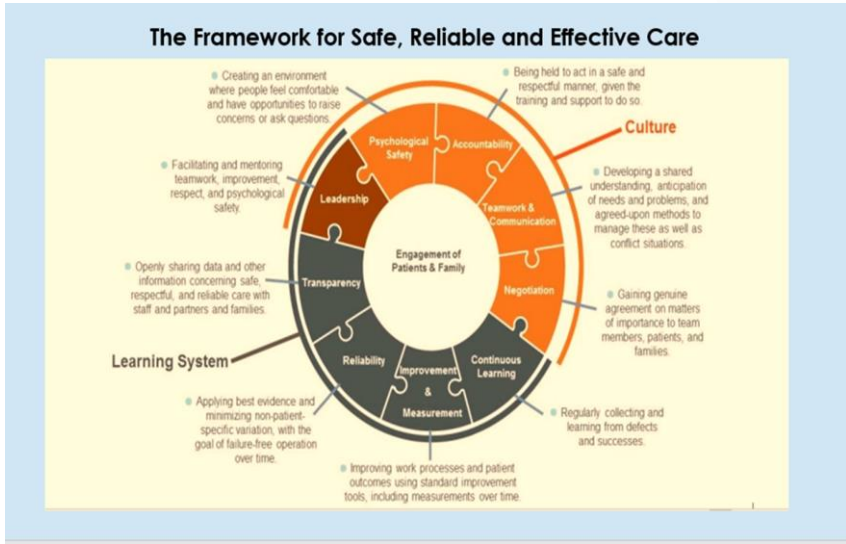
NRI & LRI
