Our response:

The CAMH Services are provided through a regional NHS network, hosted by Cwm Taf UHB to children and adolescents for the University Health Board areas of:

- Cwm Taf
- Abertawe Bro Morgannwg
- Cardiff and the Vale

The service covers a population of approximately 1.2 million people.

We are unable to provide the information you have requested in the way that you have asked. However, the information that we can provide is set out below. Please note some of these elements need to be redirected to the Welsh Health Specialised Services Committee (WHSSC):

This information is protected by the Data Protection Act 1998, as its disclosure would constitute unfair and unlawful processing and would be contrary to the principles set out in Schedules 2 and 3 of the Act. Section 40 is an absolute exemption and does not require the Health Board to consider the public interest test.
