### Freedom of Information Request: Our Reference CTHB\_295\_18

#### You asked:

From January 2017 to date (July 2018) how many discrepancy reports have been logged by the health board from Omnicell (or equivalent) medication dispensing machines?

Please give details of the medication that has the discrepancy logged against it (e.g diazepam/morphine etc) and the location of the machine where the discrepancy took place.

#### Our response:

The information provided are the 'discrepancies' for the Mediwell cabinets in Cwm Taf University Health Board.

Please note the 'discrepancies' reported below are the stock adjustments that have been made to the inventory over the requested period of time. A discrepancy occurs when there is a mismatch between the amount of stock actually there and what the system believes to be there. They are all investigated and the discrepancy is usually due to user error i.e. wrong pack size booked out. Some of these apparent errors may be duplicates i.e. the initial error and the correction and the initial error may have resulted from user error e.g. not needing the medicine after requesting it but also not recording it's return, or using 'replenish' (on the cabinet this means return into stock) when taking an item out of the Mediwell to temporarily store in another place will again generate several errors.

For example, the apparent high error rate for morphine oral solution could be because doses are sometimes given as 2.5ml but can only be booked out in whole mls so 2 or 3ml; periodically the stock volume is corrected.
