You asked:

Please can you provide the following service and maintenance contract information with regards to the organisation's fire alarms, security systems including access control.

5. Hardware Brand: The primary hardware brand of the organisation's Fire Alarms, security systems and access control systems.
6. Number of sites with Fire Alarms, security systems and access control systems
7. Contract Duration: please include any extension periods.
8. Contract Expiry Date: Please provide me with the day/month/year.

4. We can confirm that Cwm Taf Morgannwg University Health Board holds information relating to contractor spend.

However, I would like to advise you that the information you requested is being withheld under the Freedom of Information Act 2000. The exemption which the Health Board has applied to this information is: Section (43)(2) of the Freedom of Information Act.

The Health Board considers the information to be of a commercially sensitive nature and that the release of this information would or would be likely to prejudice the commercial interests of any parties concerned.

The University Health Board accepts that there is a public interest in ensuring openness and transparency however, the Health Board believes that disclosure of information in a manner which fails to protect the interests and relationships arising in a commercial context could have the effect of discouraging companies from dealing with the Health Board because of fears that the disclosure of information could damage them commercially. In turn this could then jeopardise the Health Boards ability to compete fairly and pursue its function to bring forward development in the area and obtain value for money.
