£39,908 of off framework agency expenditure has been reported for January to April 2022 all against the A&E department.

5. How much was your Off-Framework agency spend for each of the following staff groups between January 2022 – April 2022

- (a) Emergency Nurse Practitioner (ENP)**
- (b) Advanced Nurse Practitioner (ANP)**
- (c) Doctors**

£39,908 of off framework agency expenditure has been reported for January to April 2022 all against Registered Nurses.

6. Following the same breakdown of staff groups in Question 4&5, how many Off-framework shifts have been unfilled between January 2022 – April 2022?

There were 19 Off-framework shifts unfilled across the emergency department areas within the Health Board between January 2022 – April 2022. None of the 19 were in the staff groups mentioned in Q5.
