

Freedom of Information Request: Our Reference CTMUHB_375_23

You asked:

The information I require is to do with the organisation's CCTV maintenance and support contract.

Please can you send me the information stated below:

1. Supplier of the contract for CCTV maintenance and support

Openview – Security Solutions Limited.

2. How much does the Org/s spend annually with the supplier? (if multiple suppliers please list the annual spend for each)

We can confirm that Cwm Taf Morgannwg University Health Board holds information relating to supplier spend.

However, we would like to advise you that the information you requested is being withheld under the Freedom of Information Act 2000. The exemption which the Health Board has applied to this information is: Section (43)(2) of the Freedom of Information Act.

The Health Board considers the information to be of a commercially sensitive nature and that the release of this information would or would be likely to prejudice the commercial interests of any parties concerned.

As this is a qualified exemption, the Health Board must consider the public interest in deciding whether to withhold or disclose the information. The University Health Board accepts that there is a public interest in ensuring openness and transparency.

However, the Health Board believes that disclosure of information in a manner which fails to protect the interests and relationships arising in a commercial context could have the effect of discouraging companies from dealing with the Health Board because of fears that the disclosure of information could damage them commercially. In turn this could then jeopardise the Health Boards ability to compete fairly and pursue its function to bring forward development in the area and obtain value for money. As a result, exemption Section 43 is engaged as it is not considered in the public interest to disclose this information.

3. What is the renewal date of this contract?

30/09/2023.

4. What is the duration of the contract?

Six month contract extension is in place until 30/09/2023.

5. What is the review date of this contract? If possible the likely outcome of this review

As above, Health Board is considering whether to tender contract or renew for another six month extension past this date currently.

6. The primary brand of the CCTV equipment. I don't require the model just the brand. If there is various brands could you please list?

Various brands across Cwm Taf Morgannwg UHB sites – currently awaiting confirmation of full list prior to issuing for tender.

7. What is the total number of cameras in use/under this contract?

To be confirmed - Awaiting full list prior to issuing for tender.

8. The description of the services provided under this contract. Please state if this contract includes more than just CCTV services.

The contract includes intruder alarms and access control devices as well as CCTV – the contract is fully comprehensive within two geographical regions and preventative within a third at the moment the aim is to have one fully comprehensive contract once information to questions 6 & 7 above has been identified.
