Our costing teams have put together a schedule of the costs we used for the costing system for outsourcing. However, due to the way in which this information has been captured by different areas, these figures may not be robust. In addition, during Covid we were using private hospitals for activity to be carried out, as we were unable to use our hospitals. Therefore, some of the activity is not strictly outsourced during that period.
