Freedom of Information Request: Our Reference CTMUHB_202_24

You asked:

Q1. Over the past 6 months, how many adult multiple myeloma [MM] patients have you treated? If you refer your multiple myeloma patients to another centre, please state which.

Total of 29 patients.

Of those, 7 patients were treated with chemotherapy or radiotherapy at the following centres: Swansea Bay University Health Board/Velindre Cancer Centre.

Q2. Of the multiple myeloma patients over the past 6 months, how many were treated with the following:

- Belantamab Mafodotin [Blenrep] - 0
- Bortezomib [Velcade] monotherapy or with dexamethasone - **
- Bortezomib, thalidomide and dexamethasone [VTD] - **
- Bortezomib [Velcade], Melphalan/Cyclophosphamide and prednisolone/dexamethasone (VMp or VCd) - **
- Carfilzomib [Kyprolis] and dexamethasone - 0
- Carfilzomib [Kyprolis], Lenalidomide [Revlimid] and dexamethasone - 0
- Daratumumab [Darzalex] monotherapy - **

- Isatuximab [Sarclisa], Pomalidomide [Imnovid] and dexamethasone (known as IsaPd) - 0
- Ixazomib [Ninlaro], Lenalidomide [Revlimid] and dexamethasone (known as IRd) - 15
- Lenalidomide [Revlimid] monotherapy - 8
- Lenalidomide [Revlimid] and dexamethasone - 8
- Pomalidomide [Imnovid] and dexamethasone - **
- Selinexor and dexamethasone - **
- Talquetamab - 0
- Teclistamab [Tecvayli] - 0
- Any other systemic anti-cancer therapy. - ** (pan bor dex, r-benda)

Where the figures are less than 5, this has been denoted by **. The exact figures have been withheld due to the low numbers involved.

Where numbers are low we have considered that there is the potential for the individuals to be identified from the information provided, when considered with other information that may also be in the public domain. Also, responses under the Freedom of Information Act are made available to the public at large. The data is classed as personal data as defined under the General Data Protection Regulation (GDPR) and Data Protection Act 2018 and its disclosure would be contrary to the data protection principles and constitute as unfair and unlawful processing in regard to Articles 5, 6, and 9 of GDPR. We are therefore withholding this detail under Section 40(2) of the Freedom of Information Act 2000. This exemption is absolute and therefore there is no requirement to apply the public interest test.
