You asked:

Under the Freedom of Information Act 2000, I would like to request the following information regarding all current medical consultants employed by Cwm Taf Morgannwg University Health Board:

- Full name
- Medical specialty
- Primary hospital or site of work
- Professional work email address (e.g. name@wales.nhs.uk)

If individual work email addresses cannot be disclosed due to data protection reasons, I kindly request:

- Generic departmental contact emails, and
- Any official guidance on how to contact specific consultants through their respective departments.

The information was extracted from the Electronic Staff Record (ESR) – report run date 10-Apr-25.

With regards to - Professional work email address:

The Health Board is withholding the email address of these staff. This decision has been made as it is not within the expectations of the individual that their personal data would be put into the public domain. This information is classed as personal data of third parties and is therefore being withheld in accordance with section 40 (2) of the Freedom of Information Act 2000 (the Act) by virtue of section 40 (3) (a) (i) of the Act which permits a public authority to withhold personal data other than the requester's where the disclosure would breach a Data Protection Principle.

The Data Protection Act 2018 (DPA) / General Data Protection Regulation (GDPR) defines personal data as data which relates to a living individual who can be identified solely from that data or from that data and other information which is in the possession of the data controller.

Unfortunately, we do not have generic departmental contact emails.

Contacting a medical consultant, would generally be done via the GP (General Practitioner). Once the patient is referred, they will likely receive information

from the hospital or specialist team on how to contact them or they can ring the hospital switchboard and ask to speak to the relevant consultant or their secretary. Please note - Personal Information is held by Data Controllers on the basis of the exercise of functions identified in the formal notification to the Information Commissioner. Any processing of that personal information outside of those functions may be unlawful. Furthermore the General Data Protection regulation and Data Protection Act 2018 makes provision for a data subject to exercise a right to prevent processing in particular circumstances. The data subject shall have the right to object, on grounds relating to his or her particular situation, at any time to processing of personal data concerning him or her which is based on point (e) or (f) of Article 6(1), including profiling based on those provisions where personal data are processed for direct marketing purposes.

We can confirm that the individuals captured by this request have stated that they do not wish their personal data to be used for direct marketing purposes.
